Important information for Team Captains FIS EC competitions in Austria | COVID-19



Dear team captains. Please read through the following rules very carefully. These regulations are established by the Austrian Federal Ministry of Health, Austrian Ski Federation and the LOC in cooperation with FIS. It is your responsibility to inform your entire team and make sure all members follow these rules without exceptions.

1. What is important:

- Take personal responsibility very serious
- hygiene measures at all times (regular hand washing, regular disinfection)
- maintain a minimum distance of 1 meter in all areas (social distancing)
- · wear mouth and nose protection / FFP2 masks when required
 - o on the entire event site, except
 - during meal
 - during the practice of sport
 - in the start area right before the start
 - inside all buildings
 - o for all transports in buses, shuttles, gondolas, chair lifts

2. 2,5-G Status for participation:

- Each person (athletes, coaches and staff) has to present confirmation of 2,5-G status at the accredation:
 - o Fully vaccinated (Biontech/Pzifer Astra Zeneca, Moderna, Johnson&Johnson)
 - Other vaccinations will not be accepted due to Austrian Law
 - Negative PCR test (max 72 hours) Antigen Test will not be accepted.
 - o Recovered from a former Covid-19 infection (max 180 days old)
 - Transport guidelines for mountain railways (f.e. only possible with 2G) are up to the final decision of the operator.
- 3. Daily Health Questionnaire for athletes, coaches and LOC: Link through Google form.
 - Detailled information will be provided by TC
- 4. Team Captains Meeting (TCM): mostly online via Zoom Meeting. Link will be provided through OC.

5. Transportation rules for cars/team busses:

- max two people can be carried in each row of seats
- Recommendation to wear FFP2 mask during transport

6. Rules for Hotel/Accomodation:

- 2-G Status necessary & exception for professional athletes (2,5-G)
- Written confirmation (that you are a professional athlete / coach) from your NSA necessary
- Please follow individual rules / requirements from hotel / accommodation.

7. Transportation rules for gondola/chairlift:

- 2-G Status necessary & exception for professional athletes (2,5-G) may be given by the operator
- FFP2 masks mandatory for gondola
- staggered, team by team
- Please follow individual rules / requirmeents from gondolas / chairlifts.

8. Avoid crowds: inspection, toilets, gondola, chairlift

• spend your free time only with members of your team in small groups

9. COVID-19 Communication

- in case of COVID-19 symptoms immediately inform the COVID-19 Manager who is responsible for the Event (Details will be provided at the TCM)
- COVID-19 Manager activates the necessary COVID-19 measures
- all communication regarding COVID-19 must be coordinated with LOC and FIS

Entry Requirements for Austria:

With Monday, December 20th, 2021, the entry regulations for Austria have been tightened, so entry into Austria (also for Austrian citizens) is only possible with a 2Gplus certificate (vaccinated or recovered and additional PCR test) or after a booster vaccination (3rd injection) possible. If a PCR test or booster vaccination is available, NO registration via the pre-travel clearance is necessary.

If no PCR test / booster vaccination can be proven upon entry, a 10-day quarantine must be carried out. If no PCR test can be managed abroad or no PCR test result is available when entering Austria, a PCR test option can still be used in Austria, but quarantine is required until the negative test result is available. Registration via the pre-travel clearance is necessary—> https://entry.ptc.gv.at/

Austrian citizens, EU citizens and people who have a place of residence in Austria can enter Austria without 2G status (vaccinated / recovered), but must go into a mandatory 10-day quarantine, which is verified by a negative PCR test from the fifth day at the earliest test can be completed. Registration via the pre-travel clearance is necessary -> https://entry.ptc.gv.at/

Non-EU citizens CANNOT enter Austria without proof of 2Gplus, and there are no exceptions for professional reasons / top athletes.

We would like to mention, that the Entry Requirements for Austria will not be controlled by the LOC and are up to every single competitor / staff.
